BRANDING CONCEPT

ANAT's branding system visually describes the vibrant energy of the experimental arts arena.

The branding mark is spontaneous and dynamic; fusing an explosion of creativity and experimentalism, with the solidarity and strength of ANAT.

OBTAINING THE ARTWORK

ANAT's logos are provided in PDF, EPS, JPEG and PNG formats.

USAGE GUIDELINES

The ANAT logo should be used on all print and web documentation in instances of ANAT support, funding or partnerships.

Please ensure to follow the guidelines in this document to ensure the ANAT logo is used appropriately.

PRINT (CYMK) USE Choose the PDF format.

PDF is the current standard for distributing design documents. PDF's should open across all applications and operating systems.

You can open the ANAT logo pdf artwork in any vector editing program (i.e. Adobe Illustrator) to extract your logo. Alternatively, you can place or import a PDF file.

DIGITAL (RGB) USE Choose the PDF format.

The 24-bit PNG format is superior to JPG/GIF as image quality does not degrade during compression. It enables true transparency to be preserved around the edge of the artwork.

This ensures that you can use a PNG image in any digital artwork, without removing white/black backgrounds.

You can convert a PNG file into JPG, GIF or TIF in most design applications.

Do not use for print artwork.

PANTONE (SPOT) USE

Please use black or white versions of the logo artwork within all Pantone layouts.

COLOUR

Always endevour to reproduce the original colours of all ANAT logos as accurately as possible.

SIZE AND SCALE

All logos must be scaled proportionately and MUST NOT appear any smaller than 110px width (digital) or 12mm width (print).

Care must be taken to ensure that the organisation name appears with all type legible.

All ANAT logos should be equal size to all other organisational logos being displayed.

ONLINE USE

When used on digital media, the ANAT logo should be hyperlinked the relevant ANAT website. This includes websites, linkable text, enewsletters ect.

PROHIBITED USE

Please do not:

- Disproportionately scale/ distort logo
- Flip, mirror or rotate logos
- Recolour/alter/remove gradients within a logo
- Obscure a logo with another element or typeface
- Alter the typographic balance of a logo
- Add any element to a logo
- Use a scanned copy of the logo
- Apply any extra effects
